

legislation, the DRA is projected to reduce Medicare spending by 6.4 billion dollars and Medicare spending by 4.8 billion dollars. The DRA imposes spending cuts, rate freezes, and other regulatory changes impacting hospitals, physicians, home health agencies, ambulatory surgery centers, IDTFs, inpatient rehabilitation facilities, durable medical equipment suppliers, and many other sectors of the healthcare industry. The DRA also represents the first legislation implementing the new Federal quality and pay for performance initiatives. Betsy Ross is best known as the legendary maker of the first American flag, but her story is an inspirational one that goes well beyond her association with the flag. Betsy Ross was a courageous and spirited woman whose life was filled with hardships. She was shunned by her family and forbidden to worship as a Quaker for marrying a man of a different faith. She was widowed three times, and two of her seven daughters died as infants. Faced with these adversities, Betsy managed to prevail as an industrious businesswoman, running her own upholstery shop at a time when women were not given the same opportunities as men.

Tours are self-guided or visitors may purchase an audio guide which brings to life the house and extraordinary woman, Betsy Ross.

City Hall

Since no steel frame was used, the walls at the first floor are up to 22 feet thick to support all the weight from the floors above. The eight floors, each about 16 feet high, look like just three floors from the outside.

The central tower reaches a height of 511 feet. It is topped by a statue of William Penn. The massive statue is 37 feet high and weighs 27 tons. It is just one of 250 sculptures created by Alexander Calder for both the interior and exterior of the city hall. The building's more than 600 rooms are organized around a central courtyard, which can be reached via the large archways on each of the four sides.

The tower has an observation deck open to the public. Some of its beautiful interior can also be visited; go to the City Hall Tour Information Center, Room 121 at the East City Hall Entrance for information and tickets.

It was in the Assembly Room of this building that George Washington was appointed commander in chief of the Continental Army in 1775 and the Declaration of Independence was adopted on July 4, 1776. In the same room the design of the American flag was agreed upon in 1777, the Articles of Confederation were adopted in 1781, and the U.S. Constitution was drafted in 1787.


