Parallel civil and criminal actions concluded

Resolved complex parallel criminal and civil claims by state and federal authorities against a provider that allegedly violated prior HHS Office of Inspector General and state Medicaid exclusions by continuing to manage an adult facility. Our settlement reduced the proposed exclusion period, provided releases from the state, and ensured the facility's continued viability.

Corporate Integrity Agreement ends DOJ probe

Guided a client through a multiyear, multijurisdictional Department of Justice investigation following a False Claims Act whistleblower lawsuit. We handled document production, position papers, settlement negotiations, and the execution of a Corporate Integrity Agreement.

Fast-track deal saves health insurance options
