He served as an advisor to the Mayor's Office in connection with public-sector labor relations, personnel management, and civil service administration from 1983 through 1986. He was appointed in 1983 as a city alternate member of the New York City Board of Collective Bargaining. After Mr. Silverberg joined Epstein Becker & Green, Mayor Koch appointed him a full city member of the Board of Collective Bargaining, and he served in that capacity through 1993.

Mr. Silverberg frequently writes and lectures on a range of employment law topics including employment and workplace tort litigation, worker classification matters, human resource consultation and management, and military leave compliance.
