GFI Group Inc. et al.*, Case No. 10 L 4474 (Circuit Court of Cook County Nov. 2, 2015), affirmed 2017 IL App (1st) 161277-U (after two-and-a-half week jury/bench trial, court entered directed finding or directed verdict in favor of defendants on all remaining counts of the case—breach of contract, breach of fiduciary duty, fraudulent concealment, and tortious interference)

- *Intertek USA Inc. v. AmSpec, LLC, James Graca, et al.*, Case No. 14 CV 6160, 2014 WL 4477933 (N.D. IL Sept. 11, 2014) (after four-day preliminary injunction hearing, court declined to enjoin three individuals represented by Epstein Becker Green from working for co-defendant AmSpec)
- *Canon Solutions America, Inc. v. Joseph Biegler*, Case No. 12 CH 33531 (Circuit of Cook County, IL July 16, 2014) (granting default judgment in trade secret misappropriation case as a sanction for evidence spoliation and lying under oath, and awarding Canon \$297,981.04 in attorney's fees and costs)
- *Gallagher Bassett Services, Inc. v. York Risk Services Group, Inc. et al.*, 2012 IL App. (2d), slip op. (August 29, 2012) (affirming the dismissal of a five-count complaint against two former employees and their new employer for alleged violations of restrictive covenants, alleged tortious interference, and alleged trade secret misappropriation)
- *Contempo Design, Inc. v. Chicago & N.E. IL Dist. Council of Carpenters*, 226 F.3d 535 (7th Cir. 2000) (*en banc*) (affirming an award of \$445,000 against the carpenters' union for an illegal strike and declaring a collective bargaining agreement signed in order to end the illegal strike null and void)

Mr. Steinmeyer has received an "AV Preeminent" Peer Review Rating by Martindale-Hubbell, signifying the highest level of professional excellence.
